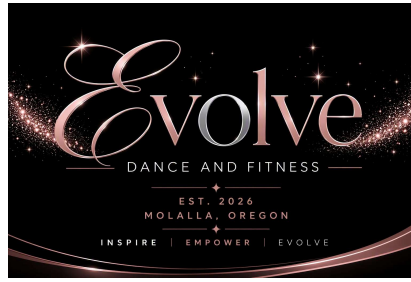
This Enrollment Agreement establishes the registration, tuition, payment, cancellation, and recurring billing terms for students enrolled in classes, programs, camps, events, or other services offered by Evolve Dance and Fitness, LLC (“Evolve”). This agreement is intended to be signed separately from the Liability Waiver, Privacy Notice, and Parent Handbook acknowledgement.

1. Enrollment and Registration

- Enrollment is subject to class availability, age or skill-level requirements, and completion of all required registration materials.
- A student is not considered fully enrolled until the registration process is complete, required agreements are accepted, and any applicable tuition or fees are paid.
- Evolve may update class placements when necessary for safety, readiness, staffing, or program fit.

2. Tuition Terms

- Tuition is charged according to the current class, program, camp, or event rate published by Evolve.
- Monthly class tuition reserves the student’s spot in the enrolled class and is not based on the number of classes attended in a particular month.



- Tuition, registration fees, costume fees, recital fees, and other program-related charges are governed by Evolve's current published rates and applicable policies. Current rates and charges will be communicated before billing.
- Monthly tuition is billed according to Evolve's current published billing schedule unless otherwise stated in writing by Evolve.

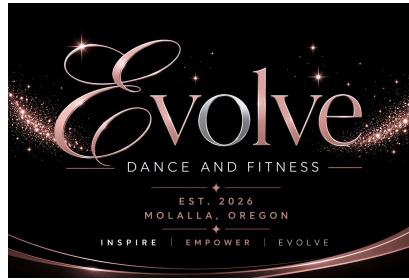
3. Payment Requirement and Accepted Payment Methods

Evolve uses Jackrabbit as its registration, billing, and payment-processing platform. Auto-pay is not required; however, all amounts due must be paid before a student participates in classes, programs, camps, events, or other Evolve services. Unless Evolve approves another arrangement in writing, tuition, registration fees, recital fees, costume fees, camps, workshops, and other authorized charges must be paid through Jackrabbit.

- Families may maintain a valid payment method on file in Jackrabbit for convenience, but auto-pay is not required unless separately agreed to in writing.
- Accepted payment methods may include credit card, debit card, ACH, bank draft, or other methods approved by Evolve through Jackrabbit.
- Cash payments may be accepted by Evolve. Check payments must be approved by Evolve before being used as a payment method.
- Evolve does not currently accept electronic payment methods outside of Jackrabbit.
- The responsible party agrees to keep any Jackrabbit payment information current and to promptly update expired, declined, or invalid payment methods if a payment method is maintained on file.
- Evolve will not pass along standard credit card processing fees to families; however, returned payment fees, chargeback fees, late fees, or other account-related fees may still apply as described in this agreement.

4. Auto-Renewal, Continuous Service, and Recurring Billing Authorization

Auto-Renewal and Continuous Service Disclosure: Monthly enrollment is a continuous service and will continue until cancelled by the responsible party in accordance with this agreement and Evolve's current published cancellation policy. By signing this agreement, the responsible party acknowledges that monthly tuition is billed according to Evolve's current published billing schedule and must be paid in accordance with Evolve's current payment policy. If the responsible party maintains a payment method on file and authorizes recurring billing through Jackrabbit, the responsible party authorizes Evolve Dance and Fitness, LLC, Jackrabbit, and any applicable payment processor to automatically charge the



payment method on file for recurring monthly tuition and any separately authorized program-related fees when due. The recurring amount will be based on the student's enrolled class, program, or membership rate shown during registration or otherwise communicated by Evolve before billing.

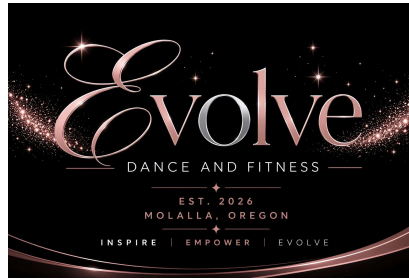
Cancellation and Revocation of Billing Authorization: Any recurring billing authorization remains in effect until enrollment is cancelled in accordance with Evolve's current published cancellation policy or until Evolve receives written notice revoking billing authorization, subject to any charges already incurred. Revoking payment authorization does not automatically cancel enrollment or waive amounts owed. To stop future tuition billing, the responsible party must submit a written drop or cancellation request through the Jackrabbit Parent Portal drop request process, if enabled by Evolve, or through another written method published by Evolve. The request must be received by the deadline stated in Evolve's current cancellation policy.

Retainable Acknowledgement: A copy of these recurring billing, continuous service, and cancellation terms will be provided or made available to the responsible party in a form that can be saved, printed, or retained. Evolve should maintain a separate registration agreement, billing authorization, and electronic acknowledgement record through Jackrabbit or another approved process.

Conflict Resolution: If this Enrollment Agreement conflicts with the Parent Handbook, Liability Waiver, Privacy Notice, registration materials, or other Evolve communications, this Enrollment Agreement controls enrollment, tuition, cancellation, recurring billing, and payment obligations unless a later written amendment expressly changes those terms and identifies the version it supersedes.

5. Returned Payments, Late Fees, and Failed Charges

- If a payment is declined, returned, reversed, charged back, later rejected after initially posting, or otherwise unsuccessful, the responsible party remains responsible for the full outstanding balance.
- Evolve may assess the following fees: a returned payment or chargeback fee equal to the bank or processor fee charged to Evolve plus a \$10 processing fee; and a \$10 late payment fee when an unpaid balance remains outstanding at the end of the five-calendar-day grace period beginning on the date Evolve notifies the responsible party that a payment was declined or failed.
- Evolve may notify the responsible party through Jackrabbit, email, or another account communication and may repost amounts due, retry payment, or require prompt payment in accordance with its current payment policy.



- Continued nonpayment may result in suspension of class participation, loss of class placement, or removal from enrollment until the account is brought current.

6. Cancellation and Drop Policy

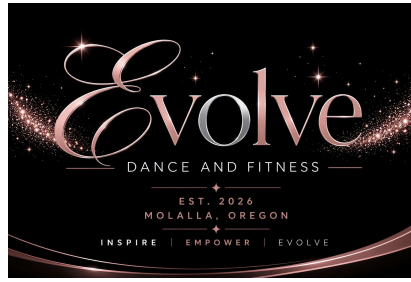
- Drop or cancellation requests must be submitted in writing through the Jackrabbit Parent Portal drop request process, if enabled by Evolve, or through another written method published by Evolve. Requests must be received by the deadline stated in Evolve's current cancellation policy.
- If timely written notice is received, cancellation becomes effective according to Evolve's current cancellation policy unless Evolve approves a different effective date in writing.
- No partial-month refunds, credits, or prorated tuition adjustments will be issued unless required by law or expressly approved by Evolve.
- Failure to attend class does not automatically cancel enrollment or stop billing.
- A drop request is not effective until Evolve receives it through an approved written method and confirms the effective cancellation date. A pending drop request does not automatically stop billing or remove the student from enrollment. Evolve will administer requests consistently with its current published cancellation policy.
- Evolve may configure Jackrabbit to reflect its current written notice requirements and cancellation procedures. A system setting does not override a timely request submitted through an approved written method or alter the controlling published policy.

7. Refunds, Credits, and Makeups

- Tuition and fees are generally non-refundable unless otherwise stated by Evolve or required by law.
- Makeup classes, credits, or substitutions may be offered at Evolve's discretion and may depend on class availability, staffing, program type, and safety considerations.
- Special event, recital, costume, camp, and workshop fees may be subject to separate refund or cancellation terms.

8. Changes to Billing or Membership Terms

Evolve will provide notice of any material change to tuition, billing, recurring payment terms, cancellation requirements, or other membership terms before the change takes effect. The notice will include information about how to cancel enrollment before the changed terms apply.



9. Parent / Guardian Responsibilities

- The responsible party agrees to review and follow Evolve's Parent Handbook, conduct expectations, attendance guidance, and communication procedures.
- The responsible party agrees to provide accurate student, parent or guardian, emergency contact, medical, and billing information.
- The responsible party is responsible for monitoring the family's Jackrabbit account, including account balances, billing notices, payment methods, transaction history, and registration communications.
- The responsible party is responsible for saving, printing, or otherwise retaining a copy of this agreement and any related billing or cancellation notices made available by Evolve or Jackrabbit.

10. Acknowledgement and Agreement

Recurring Billing and Cancellation Summary: Monthly enrollment continues until cancelled. Tuition is billed according to Evolve's current published billing schedule, and all amounts due must be paid in accordance with Evolve's current payment policy. Auto-pay is not required unless separately agreed to in writing; however, if the responsible party authorizes recurring billing through Jackrabbit, the payment method on file may be charged automatically. Cancellation requests must be submitted in writing through the Jackrabbit Parent Portal drop request process, if enabled by Evolve, or through another written method published by Evolve, and must be received by the deadline stated in Evolve's current cancellation policy. Refunds, credits, and prorated adjustments are governed by Evolve's current published policies and applicable law.

By signing below, the responsible party confirms that they have read, understood, and agree to the enrollment, tuition, payment, cancellation, recurring billing when authorized, continuous service, and Jackrabbit account terms described in this Enrollment Agreement. A copy of this agreement, including the recurring billing and cancellation terms, will be made available to the responsible party in a form that can be saved, printed, or retained.
